## Notification for Registration/Examination form (Under National Education Policy-2020) for students desiring to pursue their UG degree in private mode for Social Science/ Humanities subjects (1<sup>st</sup>-2<sup>nd</sup> Semester batch 2023)

It is notified for the information of all concerned that the date of completion of Private Registration formalities to 1<sup>st</sup> & 2<sup>nd</sup> Semester, under NEP 2020 of undergraduate program in Humanities/Social Science subject where practical subjects are not involved shall commence from 06-02-2024 to 12-02-2024 On the following terms and conditions:

- I. The candidates who have passed their 10+2 class Examination or equivalent in full shall be eligible for registration to the course.
- II. The registration cum examination form along with instructions shall be available on [www.kashmiruniversity.net](http://www.kashmiruniversity.net) (under students registration tab.) The candidates shall have to submit form online *(which can be generated only once against candidates board registration number)* at the time of his/her Registration. No separate examination form is required to be submitted.
- III. The candidates are advised to submit the Board Registration No. (as shown on 12<sup>th</sup> Marks Card) carefully or else it can lead to cancellation of form. The district should be also selected carefully
- IV. After online form submission, the candidate is required to check **MyFormStatus** (Private Mode) page available on University website for payment of prescribed fee online mode. The candidate can log in to MyFormStatus page using his/her Board Registration No and Form No (generated after submission of online form) and then opt the mode of payment as desired.
- V. As per University Statutes physically challenged and Orphan students, as evidenced by the requisite certificates from the concerned competent authorities, are exempt from payment of the examination fee. However, they shall have to pay the Registration and allied fee as is applicable to other students.  
The Assistant Registrar, Registration shall authenticate the certificates of such candidates, of being Orphan/physically challenged and accordingly the fee receipts shall be generated. In case a certificate so produced is found not genuine on verification, full fee shall be realized from such a candidate along with any other penalty as shall be decided by the University authorities.
- VI. The candidate shall submit the downloaded Registration form, along with copy of fee acknowledgement slip *(in case of payment through online mode)* or fee receipt (Payment thought receipt mode) to the Registration Section University of Kashmir with following original documents:
  - Matriculation Marks/Qualification Certificate.
  - Higher Secondary part II Marks Certificate.
  - Discharge Certificate from the last institution attended.
  - Migration certificate with Eligibility form and a fee of Rs. 100/- to be deposited in the University Chest, (where applicable).
  - Disability/Orphan Certificate for availing of fee concession where applicable.
- VII. Permission to appear in the examination will be subject to the fulfillment of eligibility criteria.

Hot & Cold charges (Rs.25/-) & Examination Management charges (Rs.12/-) to be deposited in the college concerned for each semester besides examination fee of Rs.200/- per semester for Skill enhancement courses, wherever applicable, to be deposited in the allotted college.

**Preferred Mode of Payment: -**

Total fee payable as calculated and displayed on-line by the system shall be paid by each student via the J&K Bank Internet Payment Gateway available on "MyFormStatus" Page in a single transaction using Credit Card / Debit Card / Net Banking together with the applicable transaction processing charges.

**On-line transfer of fees from any personal account directly to the University Account shall not be entertained.**

**NOTE:**

1. The registration has been considered by the authorities for the last time as special case. In light of the UGC Guidelines no such Registration in private mode for UG course in future shall be taken up by the University.
2. The candidates cannot opt such subjects as have practicals /Lab work/Map work/Surveying or field work.
3. Subjects cannot be changed after the submission of Registration/Examination form dates is closed.
4. Examination centre shall be allotted as per native districts, so the candidates shall select the same carefully.
5. The candidates who are already registered with the University either in a Private or Regular capacity and are interested to seek fresh admission under NEP 2020 shall be eligible for re-registration. However, such candidates shall have to apply for cancellation of previous admission and examination, if any. Such candidates shall be exempt from payment of University Registration fee of Rs.300/- .
6. Candidates shall have to make choice of one each of the following subjects at the time of registration.
  - a) Major Subject (from subject group I-V)
  - b) Minor Subject (from subject group's I-VI, except from the group the major subject has been chosen)
  - c) Two multidisciplinary subjects for 1st two semesters (one for 1st semester & one for 2<sup>nd</sup> semester other than the subjects chosen as major /minor without repetition)
  - d) Ability enhancement courses (one each for 1<sup>st</sup> & 2<sup>nd</sup> semesters)
  - e) Value added courses ((one each for 1st & 2<sup>nd</sup> semesters)
  - f) One skill enhancement course vertical (in consultation with the nearest college selected by the student as exam centre)
