Notice inviting e-tender for ignition of iron stoves for the winter session 2023-24 at University of Kashmir, Srinagar.

For and on behalf of University of Kashmir, e-Tenders are invited from registered manpower service providers for ignition of iron stoves for winter season 2023-24 w.e.f 16-11-2023 to 15-03-2024 in the University of Kashmir. The detailed eligibility condition, terms and conditions of the contract are given in Annexure. The rates are to be quoted as prescribed in BOQ.

Complete tender documents can be downloaded from the University of Kashmir website (<http://www.kashmiruniversity.net/tenders.aspx>). Information on issuance of corrigendum, if any, related to this tender will also be available on the same website. The submission of e-tenders shall be done through www.jktenders.gov.in.

NIT of e-Tender shall be two stages, one is Technical Bid (Documents) and another in Financial Bid (BOQ). Bids shall be accepted only in online mode through www.jktenders.gov.in.

Bid Security/ Earnest Money Deposit (EMD) of Rs.30,000/- (Rupees Thirty Thousand only) has to be submitted along with Technical Bid in the form CDR/ FDR drawn on any nationalized bank in favour of Registrar, University of Kashmir, Srinagar. Bid Security should be valid for a period of 45 days beyond the final bid validity period. In case EMD is submitted late or not submitted at all, the bid will be considered unresponsive and incomplete and will be instantly rejected.

Bid Securities (EMD) of the unsuccessful bidders shall be returned to them at the earliest after expiry of the final bid validity and latest **on or before the 30th day after the award of contract**.

All the documents forming part of technical bid shall be placed in one envelop-1 superscripted with "A-Technical Bid Documents" while all financial bid documents shall be placed in envelop-2 superscripted with "B-Financial Bid". Both the envelopes shall be placed in one big envelop superscripted with "**Tender for Ignition of Coal Stoves 2023-24**" and placed in the Tender Box available in Registrar's Office

The University of Kashmir, Srinagar reserves the right to cancel any/all the bid(s)/ tender at any time/ stage or relax/amend/withdraw any of the terms and conditions contained in the Tender Documents without assigning any reason thereof. Any query, after submission of the bid by the firm, shall not be entertained. In case of withdrawal of bid by the successful firm, the EMD will stand forfeited.

A. ELIGIBILITY, TERMS & CONDITIONS, EVALUATION OF BID.

A1. Eligibility Conditions

Following bidders/firms will be eligible to submit the Bid.

The bidder must be registered with the concerned Department for providing manpower services and must have registered office in the Kashmir province.

A2. General Terms Conditions:

1. Person signing the bid or other documents connected with tender must clearly write his/her name and also specify the capacity in which signing. The tender document must be filled in neatly and clearly. Incomplete or conditional tenders will not be entertained.
2. The rates must be written in figure as well as in words. Erasing and overwriting in the rates quoted will make the tender void.
3. University of Kashmir reserves the right to reject any or all tenders without assigning any reason thereof.
4. The agency will have to enter into an agreement with University of Kashmir before commencing the assignment.
5. After submitting the bid online hard copy of tender shall be placed in tender box available in Registrar office by or before 06-11-2023(up to 1:00 p.m) and shall be accompanied with
 - a) Bid Security of Rs.30,000/- in the shape of CDR/ FDR drawn on any nationalised bank favouring Registrar, University of Kashmir. The CDR of the successful firm will be retained by the University till the successful completion of contract and released thereafter only, while as the Bid security of unsuccessful firms shall be released after one month from the award of contract;
 - b) Registration Certificate of firm with GST clearance certificate.
 - c) Affidavit with regard to adherence of conditions mentioned below **S.No.6 to 16:**
6. The firm shall appoint **two (02)** supervisors to oversee the work done i.e; ignition of coal stoves (Conventional Bukharis) in terms of quantity and quantity who shall be responsible for communicating/ liaison with Estates functionaries and should be available during office hours;
7. The ignited iron stoves must be installed at designated places/ sections on all working days between **9:45 a.m. to 10:00 a.m. and removed 4:45 p.m.**
8. Firewood, Coal Stoves will be provided by the University. Any/all other material required shall have to be arranged by selected bidder.

9. Adequate manpower/ hand carts shall be arranged and put in place for ignition and distribution of the Bukharis to the designated places;
10. In the event of damage caused to Bukharis/furnishing/furniture or building etc. during installation and removal, the contractor shall be liable to compensate the loss;
11. No coal residue whatsoever should be thrown in corridors, stair-cases of the building/s while carrying/ removing iron stoves and arrange for its proper disposal. The coal waste should be taken out of the campus by the contractor;
12. Estates functionaries shall identify the places/ sections where Bukharis will be installed. The firm/ its manpower shall not install the Bukharis at its own;
13. Extra Bukharis after office hours or for the holidays/Examination will be intimated to the contractor by the Estates functionaries;
14. The University reserves the right to accept or reject any or all offers without assigning any reasons and without any notice;
15. In case the terms and conditions are not followed in letter and spirit by the firm/ contractor, the University reserves the right to forfeit the CDR/ FDR and also penalty on the firm.
16. One (01) worker shall be assigned ignition of maximum no. of 10 to 12 Coal stoves without fail.

A3. Evaluation of Technical Bids:

The Technical bid of the tenderers will be evaluated on the basis of conditions laid down in the notice and documents asked for in the notice.

A4. Financial Bid:

The no. of coal stoves to be installed per day is 200-250 approximately at all campuses. Manpower shall be arranged by bidder accordingly.

A4.1 Financial:

The bidders shall offer their rates/charges per coal stove basis in the BOQ. Bidders in their own interest shall offer reasonable rates and follow Labour Laws strictly in payment of all dues workers includes insurance cover.

A4.2 Financial Bids:

Financial bids of only those bidders will be opened who qualify Technical stage and bidders offering lowest rates will be awarded the contract.
