



Selection Notification No.: 03 of 2026/Self-finance
MBA and MBA-FM Programmes
[Session 2026]

- I) The Candidates, whose particulars are mentioned below have been provisionally selected for admission to **MBA and MBA-FM Programmes** offered by this University under self-finance seats quota purely on the basis of Marks obtained in the CMAT-2026.
- II) Provisionally selected candidates are required to download their “**Admission Form**” from the official website of the University under “**Admissions**” tab on the home page and click on “**Submit Admission Form for 1st Semester**” from **5th June, 2026 to 11th June, 2026** by entering **Application Form Number and DOB**.
- III) The provisionally selected candidates shall complete the admission form and visit the Department of Management Studies, University of Kashmir (MBA and MBA-FM Candidates) for **completing the admission formalities by or before 11th June 2026 (4:00 p.m.) on working days only**.

Important Note:

The Head, who is the Chairperson of the Departmental Admission Committee, shall ensure that all the provisionally selected candidates possess the minimum required eligibility. The same may be verified with reference to the original documents/certificates of the candidates. The admission form of only eligible candidates should be accepted online and may be allowed to deposit fee via online mode.

The admission of the candidates is subject to:

1. Production of all relevant original documents [Marks Certificate/Transcript of qualifying examination, Reserved Category Certificate (wherever applicable), Migration Certificate (wherever applicable)]. **However, candidates who have applied on provisional basis and whose result of qualifying examination is yet to declare shall have to submit the original documents by or before 28th July, 2026. In this regard he/she has to affirm and submit an affidavit duly sworn in before 1st Class Judicial Magistrate** stating that

“I have applied on Provisional basis and I shall submit the marks certificates of qualifying examinations by or before 28th July, 2026, failing which my candidature shall stand summarily rejected and I shall not claim refund of any dues submitted by me”.

2. Production of eligibility cum revival of registration/migration form, wherever applicable, alongwith prescribed fee;
3. Fulfilling of minimum required eligibility conditions to be verified by the concerned Department/Institute;
4. Clearance be sought from the Academic Section in respect of candidates having qualified

examination from Universities/Institutions other than Universities/ Institutions of Jammu, Kashmir and Ladakh;

5. Production of an affidavit sworn in before **1st Class Judicial Magistrate** stating that:

- ✓ **I am not on the rolls of any Institution for any Regular Mode programme;**
- ✓ **All the submitted certificates/documents are genuine and authentic;**
- ✓ **I shall strictly adhere to the rules and regulations of the University of Kashmir in toto;**
- ✓ **I understand that in case of any misinformation or concealment of any information or indiscipline or misconduct, my admission to the programme shall be cancelled and I shall be subject to legal action;**
- ✓ **I submit this affidavit under free will without any pressure, compulsion or fraud.**

6. The provisionally selected candidates shall approach, alongwith the admission form and all the relevant certificates and documents (original and self-attested Xerox copies) to the concerned Department/Institute for verification of documents/certificates and online acceptance of Admission form for depositing the prescribed Fee via online mode upto **11th June, 2026 (upto 4:00 pm)**.
7. Any provisionally selected candidate **failing to complete the admission formalities upto 11th June, 2026 (4:00 p.m.) shall forfeit his/her right to admission** and the resultant vacancy (ies), if any, shall be filled up from among the waiting list.
8. The Head, Department of Management Studies is hereby informed to kindly forward the vacancy list (if any) on **11th June, 2026 upto 04:45 p.m.**, so that waiting list is operated.
9. Please note that all the Notifications shall be made available only on the Official website of the University and notices shall neither be published in print media nor shall any candidate be informed individually.
10. **Notices uploaded on the official website of the University shall be deemed to have been served to all the candidates.**
