PG and LL.B. Programmes (Session 2025)

- I) Candidates, whose particulars are mentioned in the selection lists appended to this notification, have been provisionally selected for admission to **PG and LL.B. programmes** (Non-Professional and Professional) offered by this University purely on the basis of merit obtained by them in the Kashmir University Entrance Test-2025 or on the basis of Qualifying Merit as per admission policy.
- II) Provisionally selected candidates are required to download their "**Admission Form**" from the official website of the University under "**Admissions**" tab on the home page and click on "**Submit Admission Form for 1st Semester**" from **5th August 2025 (Tuesday)** by entering the login details.
- III) The provisionally selected candidates shall complete the admission form and visit the concerned Department/Centre for completing the admission formalities by or before **Friday, 8th August 2025 (4:00 p.m.)**.

Important Note:

The Heads/Directors/Coordinators/Principals of all the concerned Departments/Institutes/Centres/Campuses/affiliated Colleges who are the Chairpersons of Departmental Admission Committee, shall ensure that all the provisionally selected candidates possess the minimum required eligibility and have passed their qualifying examination/have category certificate (if selected under any reserved category) issued by or before 1st August 2025 (the last date for fulfilling eligibility conditions). The same may be verified with reference to the original documents/certificates of the candidate. The admission form of only eligible candidates should be accepted online and provisionally selected candidates allowed depositing online fees.

The admission of the candidates is subject to:

1. Production of all relevant original documents [Marks Certificate/Transcript of qualifying examination, Domicile certificate (other than OSJ), Character and Provisional certificates of the Institution last attended, valid Reserved Category certificate (wherever applicable), Migration Certificate (wherever applicable). [Sufficient time should be given for producing migration certificate, as this has to be obtained from the previous institution, till then candidates be asked to submit plain undertaking that they shall produce the certificate at the earliest]


Note: Since result has been recently declared and most of the candidates have to seek exit from their colleges, they may be allowed to submit NAD generated 'semester-wise marks cards' till they get the Official Transcript from the University.

2. Production of eligibility cum revival of registration/migration form wherever applicable alongwith prescribed fee;
3. Fulfilling of minimum required eligibility conditions to be verified by the concerned Department;
4. Clearance be sought from the Academic Section in respect of candidates having qualified examination from Universities/Institutions other than Universities/Institutions of Jammu & Kashmir;
5. Production of an affidavit sworn in before **1st Class Judicial Magistrate** stating that:

- ✓ I am not on rolls of any Institution for any regular programme;
- ✓ All the submitted certificates/documents are genuine and authentic;
- ✓ I have not availed the benefit of the reserved category certificate for pursuing any PG Programme earlier (if seeking admission under any Reserved Category);
- ✓ I shall strictly adhere to the rules and regulations of the University of Kashmir *in toto*;
- ✓ I understand that in case of any misinformation or concealment of any information or indiscipline or misconduct, my admission to the programme shall be cancelled and I shall be subjected to legal action;
- ✓ I submit this affidavit under free will without any pressure, compulsion, fraud or coercion.

6. The provisionally selected candidates shall approach, alongwith the admission form and all the relevant certificates and documents (original and self attested Xerox copies) to the concerned Department/Institute for verification of documents/certificates and online acceptance of Admission form for depositing the prescribed Fee via online mode from 5th to 8th August 2025.
7. Any provisionally selected candidate failing to complete the admission formalities upto 8th August 2025 (4:00 p.m.) shall forfeit his/her right to admission and the resultant vacancy (ies), if any, shall be filled up from among the waiting list. A candidate, who forfeits admission, shall not be given another chance till candidates are available in the merit list.
8. The Heads/Directors/Principals are hereby informed to kindly forward the category wise vacancy list (if any) upto 04:30 PM on the last date prescribed for completion of admission related formalities so that waiting list is operated.
9. Please note that all the Notifications shall be made available only on the Official website of the University and no Notice shall be published in print media nor shall any candidate be informed individually.
10. Notices uploaded on the official website shall be deemed to have been served to the candidates.
