Consequent upon the vacancies created due to non-completion of admission formalities by some candidates, he candidates the candidates whose particulars are mentioned below have been selected provisionally against the ST and SN category for perusing 4-Year B. Sc. Nursing Course at the **University of Kashmir, South Campus, Anantnag** purely on the basis of merit obtained in the Entrance Test. The admission of the candidates is subject to:-

- 1. Production of all relevant original documents {Marks Card/s of qualifying examinations, State Subject certificate, Character, Reserved Category Certificate (wherever applicable) and Provisional certificates of the Institution last attended};
- 2. Fulfilling of minimum required eligibility conditions to be verified by the concerned Campus;
- 3. Production of an affidavit sworn in before 1st Class Magistrate stating that:
 - I am not on rolls of any Institution;
 - o All the submitted certificates/documents are genuine;
 - I have not availed the benefit of the reserved category certificate for pursuing any UG Programme earlier (if seeking admission under Reserved Category);
 - o I shall strictly adhere to the rules and regulations of the University in toto;
 - O I understand that in case of any misinformation or concealment of any information or indiscipline or the certificates/documents submitted by me are not genuine or incomplete in any respect or don't fall within the age limit of 17-25 years (in case of Male candidate) and 17-28 years (in case of Female candidate) as on last date prescribed for submission of On-line Application Form, my admission to the course shall be cancelled and I shall be subjected to legal action;
 - o I submit this affidavit under free will without any pressure, compulsion, fraud or coercion.

The provisionally selected candidates shall approach, alongwith all the relevant original certificates and self attested Xerox copies of certificates/documents to the concerned Director of the Campus for completion of admission related formalities by or before 13th June, 2018. Any provisionally selected candidate, failing to complete the admission formalities by 13th June, 2018, shall forfeit his/her right to admission and the resultant vacancy (ies), if any, shall be filled up on the basis of merit among the candidates in the waiting.

Important:-

- The candidates in waiting list are directed to approach the office of the South Campus for admission against the vacant seat (if any) on 14th June, 2018 upto 4:00 PM, any candidate fails to approach on the said date shall have no claim for admission to the course if having higher merit than the selected candidate (approaching in due time);
- The office of the South Campus my consolidate the applications submitted by the candidates in waiting list willing to join the Campus and approaching within the
 stipulated date and time. Accordingly, the said applications be forwarded to the Directorate of Admissions & Competitive Examinations duly signed/forwarded by
 the Director of the Campus for authorization of their admission against the vacant seats.
