On-line Applications are invited from the eligible candidates for two (2) Ph.D. positions form scholars interested in research to join as Ph.D. scholars at University of Kashmir. The scheme is available for the Ph.D. candidates in the research topic which come under the broad research categories of Electronics Design and Manufacturing (ESDM) and Information Technology Enables Services (ITES). The scheme is not available for candidates who are already enrolled fro Ph.D. programme at University.

Ministry of Electronics and Information Technology (MeitY), Government of India;

V) Fellowship and Benefits:

- a) Fellowship: Rs. 38750/- per month (I&II Years); Rs. 43750/- per month (III Year onwards);
- b) Reimbursement of Rent (ROR): Class Y @ 16%;
- c) Research Contingency Grant support of Rs. 1,20,000/- per year during the duration of the Ph.D.;
- d) Support for attending International Conferences;

VI) Duration of Fellowship:

Five (5) years or the Ph.D. duration whichever is less;

VII) Eligibility:

Masters in Science/Engineering/Technology in Electronics, Computers or Information Technology;

IX) Admission Procedure:

> Selection shall be made through a written entrance test. The entrance test syllabus is available on the University website. A candidate may choose any one of the themes (Electronics and Computer/IT) for the written test.

X) Submission of On-Line Application Forms:

The candidates are advised to follow the following steps for filling their On-Line Application Forms:

- **Step-1: Visit** http://www.kashmiruniversity.net or www.kashmiruniversity.ac.in and click on Link **Admissions.** Read Important Instructions for Registration and Submission of Form carefully before proceeding further.
- **Step-2:** Login into the system for submitting On-line Application Form. Enter your "Registration No." and Click "Next".
- **Step-3:** Enter the required details and Upload your latest passport size Photograph and click "Next".
- **Step-4:** Select the desired Preferences (After On-line submission the Preference of Campus selected will not be updated/changed). Click "**Next**".
- **Step-6: Deposit** non-refundable Application Fee of **Rs. 250/- (including IT Fee of Rs. 150/-)** plus Entrance Test Fee of **Rs. 500/-** i.e **Rs. 750/-** through Online mode only.
- **Step-5:** If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click "Submit". Get a printout of the Form.

XI) Submission of downloaded Application Form (Hard copy):

• After submitting the On-Line Application Form, candidate need to submit the downloaded Form (hard copy) alongwith all marks certificates of the qualifying examinations and other related documents in the <u>Directorate of Admissions and Competitive Examinations</u>, <u>University of Kashmir by or before 21-12-2022 upto 04:30 PM</u>.

XII) Verification of documents/certificates:

- The selection of the candidate will be rejected if it is found that the applicant does not fulfill the eligibility criteria or has misrepresented/suppressed the information.
- The candidates are informed that they need to produce all the original certificates/documents at the time of joining (if selected) in the concerned Department.

XIII) Additional information:

- No TA/DA shall be paid to the candidates for attending the interview or joining the position;
- The fellowship is for a time bond project and the selected candidates are required to work dedicatedly for the successful completion of the project;

- The fellowship shall be granted according to the terms and conditions under the scheme of MeitY and the Ph.D. programme shall be governed by the UGC and University of Kashmir Ph.D. regulations;
