<u>Selection Notification No.: 13 of 2024</u> <u>3-Year LL.B and MA History Programmes</u> (Supplementary/2nd Shift)

Consequent upon the seats which remained vacant due to non-completion of admission formalities by some candidates, the candidates whose particulars are mentioned below have been selected provisionally for admission to **3-Year LL.B. and MA History Programmes (Supplementary/2nd Shift)** offered at Main Campus purely on the basis of merit obtained by them in the Kashmir University Entrance Test- session 2024.

Important Note:-

<u>The Heads/Directors/Coordinators of all the concerned Departments/Institutes/Centres/Campus who are the</u> <u>Chairman of the Departmental Admission Committee, shall ensure that all the selected candidates possess the</u> <u>minimum required eligibility and have category certificate (if selected under any reserved category valid upto</u> <u>27-06-2024) the same may be verified by the original documents/certificates of the candidate. No authority slip</u> <u>shall be issued by the Chairman of the Admission Committee to the candidate who aren't eligible and having</u> <u>category certificate issued after the above mentioned dates.</u>

The admission of the candidates is subject to:-

- 1. Production of all relevant original documents {Marks Card/s of qualifying examination, Domicile certificate, Character and Provisional certificates of the Institution last attended (if applicable), valid Reserved Category certificate (wherever applicable), Migration Certificate};
- 2. Production of eligibility cum revival of registration/migration form wherever applicable alongwith prescribed fee;
- 3. Fulfilling of minimum required eligibility conditions to be verified by the concerned Department;
- 4. Clearance be sought from the Academic Section in respect of candidates having qualified examination from Universities/Institutions other than Universities/Institutions of Kashmir Division and Jammu University;
- 5. NOC from the concerned Department in case of In-service candidates;
- 6. Production of an affidavit sworn in before 1st Class Judicial/Executive Magistrate stating that:
 - I am not on rolls of any Institution;
 - All the submitted certificates/documents are genuine;
 - I have not availed the benefit of the reserved category certificate for pursuing any PG/UG Programme earlier (if seeking admission under Reserved Category);
 - \circ I shall strictly adhere to the rules and regulations of the University in toto;
 - I understand that in case of any misinformation or concealment of any information or indiscipline, my admission to the programme shall be cancelled and I shall be subjected to legal action;
 - \circ I submit this affidavit under free will without any pressure, compulsion, fraud or coercion.

The provisionally selected candidates shall download their online Admission Forms from official website of the University of Kashmir <u>www.kashmiruniversity.net</u> from 15-10-2024 by entering their Entrance Test No. and shall have to approach alongwith all the relevant original certificates and self attested Xerox copies of certificates/documents to the concerned Department/Institute/Campus/Colleges for verification

of documents/certificates and acceptance of Admission form for depositing the prescribed Fee online mode from 15-10-2024 to 18-10-2024 (working days only). Any provisionally selected candidate failing to complete the admission formalities upto 18-10-2024 shall forfeit his/her right to admission. The Heads/Directors/Principals are hereby informed to kindly forward the vacancy list (if any) upto 05:15 PM on the last date prescribed for completion of admission related formalities. Please note that all the Notifications shall be made available only on the Official website of the University and no Notice shall be published in print media.
