I) Eligibility:

The candidates must have passed 3-year Diploma in any branch with at least 50% marks from Jammu and Kashmir Board of Technical Education or from a recognized University/Board or B.Sc. graduates with Mathematics as one of the subjects from a recognized University, with a minimum of 50% marks in aggregate. However, the candidates applying under any reserved category shall have obtained at least 45% marks in 3-Year Diploma programme.

Furthermore, candidates having appeared or appearing in the qualifying examination can also apply provisionally on their own risk and responsibility, subject to fulfilling all eligibility conditions including acquiring minimum required percentage by or before 29th July, 2025.

II) Important dates:

- On-line submission and last date for Application Forms including deposition of fee is from 04-07-2025 to 14-07-2025
- > All dates notified are final and no extension shall be granted.

III) Submission of On-Line Application Forms:

The candidates are advised to follow the below steps for filling of On-Line Application Forms.

Step-1: Visit http://www.kashmiruniversity.net or www.kashmiruniversity.ac.in and click on "Admissions" tab on homepage.
Step-2: Click on the link for "Application Forms for 4-Year B.Tech Programme" and enter your JKBOSE/CBSE "Registration No." and Click "Next".
Step-3: Enter the required details and Upload your latest passport size Photograph and click "Next".

Step-4: Select the desired Campus Preferences (After last date the Preference of Campus selected will not be updated/changed). Click "<u>Next</u>".

Step-5: If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click "Submit". Get a printout of the Form and note the Form No. for future reference.

Step-6: Deposit the non-refundable "Application Fee of Rs. 400/- (including Rs. 150/- as IT Fee) andEntrance Test fee of Rs. 500/-" i.e. Rs. 900/- through Online mode only.

Step-7: Applicant can view the Application details by providing username and password. Applicant is required to make sure that **"Application Status"** on application form is **"Fee Received"** after 2 days otherwise application will be treated as incomplete and summarily rejected.

Step-8: Candidates in their own interest are advised to apply & submit application promptly and not to wait till the last date/time for applying online. Directorate shall not be responsible if candidates are not able to submit their applications on account of the last-minute rush. Please retain print-out of application form for future references.

IV) Hard Copies of the Application Forms and fee receipt :

Candidates need not submit the hard copy of the Application Form nor of fee receipt; however, they must take printout of the online submitted Application Form and fee receipt and retain it for future reference.

V) Disclaimer:

Directorate will not check/verify the educational/category certificates etc. of the candidates at the time of Online submission of application form for appearing in the written examination and it will be the sole responsibility of the candidate to ascertain that he fulfills all the eligibility criteria for admission to the programme he/she is applying for. However, the documents will be verified by the concerned Department at the time of completion of admission related formalities in respect of the selected candidates to a particular programme. The admission of the selected candidate will be rejected at any time if it is found that the applicant does not fulfill the eligibility criteria or has misrepresented/concealed any facts/information;
