2-year M Sc Biotechnology Programme (Non-GAT-B)

(Self-finance Quota)

On-Line Applications are invited from eligible candidates (**Non-GAT-B**) for admission to **M Sc Programme in Biotechnology (available under Self-finance quota only)** for the academic session 2024 offered at Department of Biotechnology, University of Kashmir Admission to the programme shall be governed by the Admission policy available on University website and relevant statutes governing the programme.

i) Important dates:

- On-line submission and last date for Application Forms **including deposition of fee is from 16-07-2025 to 22-07-2025**

ii) Eligibility:

Applicants should have passed, Bachelor's degree under 10+2+3 pattern in Physical, and Biological Sciences OR Bachelors degree in Agricultural, Veterinary and Fishery Science, Pharmacy, Engineering/Technology or Medicine (MBBS) or BDS from the University of Kashmir or any other Institute **recognized by UGC** with at least 55% marks in aggregate for Open Merit and 50% marks for reserved categories.

iii) Admission Criteria:

The selection to the programme shall be made on the basis of entrance to be conducted by the University of Kashmir;

iv) Submission of Online Application Forms:

The candidates are advised to follow below mentioned steps for filling their Online Application Forms: -

Step-1: Visit <http://www.kashmiruniversity.net> or www.kashmiruniversity.ac.in and click on Link Admissions

Step-2: Enter your Board "Registration No." and Click "Next".

Step-3: Enter the required details and Upload your latest passport size Photograph and click "Next".

Step-4: If there is any variation click on "Previous" button, make necessary corrections and then Click "Submit". Get a printout of the Form and note the Form No. for future reference.

Step-5: Deposit the non-refundable "Application Fee of Rs. 400/- (including Rs. 150/- as IT Fee) and Processing fee of Rs. 500/- for one programme i.e. Rs. 900/-" through Online mode only.

v) Hard Copies Application Forms and fee receipt :

Candidates need not to submit the hard copy of the Application Form nor of fee receipt; however, they must take printout of the online submitted Application Form and retain it for future reference.

vi) Disclaimer:

Directorate will not check/verify the educational/category certificates etc. of the candidates at the time of Online submission of application form for appearing in the written examination and it will be the sole responsibility of the candidate to ascertain that he fulfills all the eligibility criteria for admission to the programme he/she is applying for. However, the documents will be verified by the concerned Department at the time of completion of admission related formalities in respect of the selected candidates to a particular programme. The admission of the selected candidate will be rejected at any time if it is found that the applicant does not fulfill the eligibility criteria or has misrepresented/concealed any facts/information;

- **Submission of Application Forms is subject to determination of eligibility for admission to the Programme by reference to the Admission Policy-2025;**
