Applications are invited from the domicile of J&K for one post each of **Field Investigator (FI), Upper Division Clerk (UDC) and Peon**, purely on contractual basis initially for a period of one year which may be extended up-to the maximum of three years (year-on-year basis depending on the performance of the candidate and continuation of funding from MoHFW for these posts) on consolidated salaries. **The eligible candidates need to fill the google forms in the available link on the PRC website- <http://prcku.uok.edu.in> by 10th August, 2025 till 5.00 PM.**

The walk-in-interview for the engagement of one post each as **Research Fellow-I, and Research Fellow-II**, purely on contractual basis initially for a period of one year which may be extended up-to the maximum of three years (year-on-year basis depending on the performance of the candidate and continuation of funding from MoHFW for these posts) in the Population Research Centre, University of Kashmir, is scheduled on **07.08.2025** at 10.00 AM in the Office of the undersigned. 5. All enclosures attached to the **Google Application Form** should be self-attested, and the candidates shall have to produce the original documents relating to their age, qualifications, experience, fitness, and other claims whatsoever at the time of interview.

7. The University reserves the right not to fill-up any of the vacancies advertised, if circumstances so warrant, without assigning any reason thereof.
8. The University shall verify the antecedents of all documents of the candidates submitted at any time of appointment or during the tenure of service. In case it is detected that the documents submitted are fake or the candidate has clandestine antecedents/background and has suppressed the said information, his/her services shall be terminated forthwith, and the action shall be taken as warranted under the rules.
